





Towards a National Strategy in advancing cross-border paperless trade in Turkmenistan

Meeting with national stakeholders

20-21 May 2024

CONCEPT NOTE AND PROGRAMME

1. Introduction

Turkmenistan acceded to the Framework Agreement on Facilitation of Cross-Border Paperless Trade in Asia and the Pacific (CPTA) on 4 May 2022. Since then, Turkmenistan has been actively engaged in implementing CPTA. In this endeavor, the Secretariat of the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP) and the United Nations Resident Coordinator's Office in Turkmenistan, with the support of national and international consultants, have carried out a readiness assessment for cross-border paperless trade and study report was published on 21 December 2022¹.

During the second session of the Paperless Trade Council held on 22-23 June 2023, the Council noted the importance of initiating pilot projects on cross-border paperless trade. It recommended that the Secretariat conduct a comparative analysis of the benefits of exchanging selected trade-related documents electronically and the readiness of all parties to undertake such an initiative, as well as to identify differences in the policies, laws, and infrastructure capabilities of each member State as a basis for narrowing those gaps and present the results of that analysis to the Standing Committee at its third session.

Subsequently, this issue was discussed at the ad-hoc session of the Standing Committee held on 23 and 24 January 2024. Considering the large number of trade-related documents to be studied, it is essential to prioritize them. In this connection, the Secretariat proposed four selection criteria: 1) The documents (paper or paperless) should be commonly used by all or most of the Parties; 2) The electronic documents, ideally, should have been adopted by at least one Party of CPTA (so that the operation can potentially be expanded to other Parties); 3) Low hanging fruit: the paperless solution should be relatively easily acceptable by the Parties; 4) The documents, ideally, should also be recommended by ICC and other development partners so that synergies can be explored. Based on these criteria, the Secretariat proposed that the first phase of the studies should cover three documents, namely, a Certificate of Origin (including preferential and non-preferential), a Phytosanitary certificate, and a Commercial Invoice. Secretariat invited the Parties to join the studies depending on the willingness and readiness of each Party.

2. Objectives

To support Turkmenistan in further advancing cross-border paperless trade and effectively implementing CPTA, this meeting with national stakeholders has several objectives.

- To enhance awareness of different stakeholders, including different government agencies, business sector and other pertinent stakeholders on the nature and importance of CPTA.
- To identify short-, medium-, and long-term national cross-border paperless trade plans.
- To support Turkmenistan in identifying the benefits of exchanging selected trade-related documents electronically and the readiness of the country to undertake such an initiative as per recommendation by the paperless trade council.
