In addition, on the sidelines of SAES, UNESCAP organized a roundtable on supporting SDG achievement through building analytical capacity in South Asian LDCs responding to the requests for technical assistance made by Afghanistan and Bhutan in which heads of South Asian think-tanks participated. 9. SOUTH ASIAN LEADERS HIGHLIGHT INITIATIVES TOWARDS SUSTAINABLE DEVELOPMENT GOALS (SDGs) AT THE UN-GENERAL ASSEMBLY



Bangladesh:

H.E Ms. SHEIKH HASINA, Prime Minister of Bangladesh, said that despite turbulence in the rule-based international order and apprehensions of gradual economic slowdown, her country has continued to prosper over the last 10 years. “Poverty eradication, sustainable growth, protection of the environment, and human-resources development are some of the key features of our development strategy,” she added. Over the past 10 years, Bangladesh has adopted progressive and timely policies. Its exports grew three times from 2005 to 2018. Bangladesh has achieved one of the fastest poverty reduction rates in the world, with the poverty rate dropping from 41.5 percent in 2006 to 21.4 percent in 2018. Bangladesh is addressing inequality through social security, decent work, and financial inclusion.

“We are investing in human capital to create an inclusive society through equal access to technology,” she continued, noting the countrywide 5,800 digital centers taking 600 e-public services to people’s doorsteps. Bangladesh has long advocated for addressing the special challenges and vulnerabilities of countries. In that regard, it has adopted transformative and innovative climate-resilient technologies and crops for reducing disaster risks.



Bhutan:

H.E Dr. LOTAY TSHERING, Prime Minister of Bhutan, said that his campaign commitment to “narrowing the gap” was consonant with the 2030 Agenda’s pledge to leave no one behind. Noting that free health care and education are constitutionally mandated for all citizens, he said that, despite being a resource-constrained country, Bhutan prioritizes the social sector. Teachers are now the highest-paid civil servants, and the Government plans to launch many maternal health initiatives, including one intended to provide prenatal and antenatal care, he said, pointing out that this is in addition to the totally free secondary and tertiary health-care system. Bhutan will achieve universal health coverage well ahead of 2030, he added.

Highlighting his country’s carbon-negative status, for which he thanked its “visionary monarchs,” he credited the national philosophy of “development with values” for Bhutan’s extensive forest cover, which stands at 72 percent. He went on to touch on the Government’s environment-friendly construction policies, its use of renewable energy sources and its initiatives to replace fossil fuels with clean energy. “Ironically, these contributions are rendered futile by the choices of others,” he said, noting that those who can are not doing enough. “If we do not intervene, we will have an incurable, diseased planet,” he warned.

Concerning the 2030 Agenda, he said Bhutan is committed to “being an early achiever,” recalling that the Government presented its voluntary national review last July and will present another in 2020. He went on to state that, as part of its planned graduation from least developed country status in 2023, Bhutan has identified critical sectors upon which to focus in this regard, including sustainable water, waste management, and organic agriculture. Challenges that remain to be addressed include ensuring that climate change and natural disasters do not impoverish vulnerable populations, he said, while noting that inadequate resources are a hurdle.



India:

H.E Mr. NARENDRA MODI, Prime Minister of India, highlighted some achievements of his Government towards SDGs priorities. ‘When a developing country successfully runs the world’s biggest health assurance scheme, giving 500 million people 500,000 rupees annually for free treatment, the gains from that scheme show the world a new path’.

‘And when a developing country launches for its citizens the world’s largest digital identification program — giving them a biometric identity and saving more than \$20 billion by checking corruption — the modern systems that result from this project give the world new hope. By 2022, when India celebrates its 75th Independence Day, it plans to build 20 million houses for the poor’, he said. It will also work to eradicate tuberculosis by 2025. Such rapid changes are taking place in India because India is a great culture that is thousands of years old, one with its own vibrant traditions and which encompasses universal dreams. The core of India’s approach is public welfare through public participation.

Viewed from a historical and per capita emission perspective, India’s contribution to global warming is very low, he said. Yet, the country is a leader in addressing this issue. Among the effects of global warming is the increasing number and severity of natural disasters. As such, India has initiated a “Coalition for Disaster Resilient Infrastructure” to build infrastructure that withstands natural disasters. With technology bringing about sweeping change to social, personal, and economic life, as well as to security and international relations, “a fragmented world is in the interests of no one. We do not have the option to confine ourselves within our boundaries,” he said. “We must give a new direction to multilateralism and the United Nations.”



Maldives:

H.E Mr. IBRAHIM MOHAMED SOLIH, President of Maldives, said that the climate crisis is looming larger than ever, “heightened by our collective inability to address it,” he noted. Recalling the creation of the United Nations after the Second World War, he emphasized that it is needed to face the current global problems, which can only be solved through collective efforts. He went on to state that climate change remains the most pressing issue for the Maldives, an insular State, emphasizing: “It threatens our very existence as a nation.” The Government has revised and scaled up its nationally determined contributions arising from the Paris Agreement, he said, explaining that his country has presented a plan that seeks to utilize natural solutions, promote innovation and introduce such measures as a complete ban on single-use plastics by 2023 and further protection of marine areas, hopefully with the support of the international community.



Nepal:

H.E Mr. PRADEEP KUMAR GYAWALI, Minister for Foreign Affairs of Nepal, stated that the challenges the world faces today — such as increasing inequality, trade tensions, and climate change — create insecurity and disorder that hurts least-developed countries, landlocked developing countries and small island developing States the most. Despite the negligible emissions of these States, they will face disproportionate, unjust and undue existential consequences. A report by the International Centre for Integrated Mountain Development reveals that one-third of glaciers in the Hindu Kush and Himalaya ranges will melt by the end of this century, even if the world meets its 1.5°C commitment. To address this, Nepal will convene a global dialogue on climate change in April 2020 to deliberate on issues of contemporary importance.
