

I. Key Activities during Oct - Dec 2021

1. Fifth South Asia Forum on the Sustainable Development Goals calls for building back better from COVID-19 while accelerating the implementation of the SDGs in South and South-West Asia



Colombo, Sri Lanka 15-16 November 2021. The Fifth South Asia Forum on the Sustainable Development Goals (SDGs) was jointly organized by the ESCAP Subregional Office for South and South-West Asia (ESCAP-SSWA) and the Government of Sri Lanka in a hybrid format. The two-day subregional preparatory meeting brought together stakeholders from the government, the international community, civil society, academia and the private sector to discuss achievements and challenges in the process of implementation of the 2030 Agenda; assess progress on the thematic SDGs for review by the Asia Pacific Forum for

Sustainable Development and High-Level Political Forum in 2022; and advance regional cooperation to build back better from the pandemic. The opening session of the Forum was addressed by H.E. Mr. Mahinda Rajapaksa, Prime Minister of Sri Lanka; Ms. Armida Salsiah Alisjahbana, Under-Secretary-General of the United Nations and Executive Secretary of ESCAP; Mr. Esala Ruwan Weerakoon, Secretary-General of SAARC; Ms. Fathimath Niuma, Deputy Minister, Ministry of National Planning, Housing and Infrastructure, Maldives; Dr. Biswo Nath Poudel, Vice-Chairman, National Planning Commission, Government of Nepal; and Mr. Asad Umar, Minister for Planning, Development & Special Initiatives, Pakistan. For the inaugural session, Mr. Anusha Palpita, Secretary, Ministry of Economic Policies & Plan Implementation, Sri Lanka; Mr. Adnan Aliani, Officer-in-Charge, ESCAP-SSWA; and Ms. Hanaa Singer-Hamdy, UN Resident Coordinator, Sri Lanka, gave welcome remarks. H.E. Mr. Mahinda Rajapaksa, Prime Minister of Sri Lanka, affirmed that "the theme of this year's forum is timely and relevant, as we strive to build back better and stronger from the global pandemic that [has] resulted in devastating consequences for our economies and societies." Ms. Armida Salsiah Alisjahbana, United Nations Under-Secretary-General and ESCAP Executive Secretary, also noted, "We have to adopt a strategy for judiciously utilizing the resources and opportunities available to us to address both the immediate concerns of recovery from the pandemic, and the long-term requirements of resilience and sustainability of our economies." The ESCAP report "Achieving the SDGs in South Asia- An Integrated Approach to Accelerate SDG Progress and COVID-19 Recovery" was also presented at the Forum. The report puts forward five critical areas of policy reforms that could contribute to the implementation of the 2030 Agenda. More than 750 participants attended the event in person and virtually. # 2. Policy Dialogue on Regional Cooperation for Sustainable Development in South Asia



Colombo, Sri Lanka 17 November 2021. The ESCAP Subregional Office for South and South-West Asia (ESCAP-SSWA), in collaboration with the Sustainable Development Council of Sri Lanka and the Institute of Policy Studies of Sri Lanka, organized a Policy Dialogue on strengthening subregional linkages towards inclusive growth and sustainable development outcomes. The opening session was addressed by Mr. Tharaka Balasuriya, State Minister of Regional Cooperation, Sri Lanka; Mr. Esala Ruwan Weerakoon, Secretary General, SAARC; Ms. Fathimath Niuma, Deputy Minister, Ministry of National Planning, Housing and Infrastructure, Maldives; Mr. Adnan Aliani, Officer-in-Charge, ESCAP-SSWA; Dr. Dushni Weerakoon, Executive Director, IPS, Sri Lanka; and Ms. Chamindry Saparamadu, Director General, Sustainable Development Council, Government of Sri Lanka. Mr. Tharaka Balasuriya, State Minister of Regional Cooperation, Sri Lanka, highlighted in his inaugural address that the deepening of intra-regional trade, technology transfers, and collaboration are important for development. Mr. Esala Ruwan Weerakoon, Secretary General of the South Asian Association for Regional Cooperation underscored the criticality of strengthening the means of implementation and partnership towards the achievement of the Sustainable Development goals, and the need for all stakeholders to work collectively to build back better. The dialogue brought together regional policy thinktanks, representatives of governments, academia, civil society organizations, media, and other key stakeholders from South Asian countries to deliberate on topics such as deepening intra-regional trade and investment relations in the aftermath of COVID-19, improving transport and energy connectivity, promoting subregional cooperation mechanisms to address the threat of climate change, and framing of future agenda for the South Asia Network for SDGs (SANS). 3. Regional and national focused online training courses on ecommerce and digital marketing conducted for women entrepreneurs of South Asia





New Delhi, India 4-6 October / 20-21 December 2021. The ESCAP Subregional Office for South and South-West Asia (ESCAP-SSWA), in partnership with the Enhanced Integrated Framework, South Asian Network on Sustainable Development Goals and South Asia Women Development Forum, held a regional online training course for women entrepreneurs from 4 to 6 October 2021. Another national online training was organized by ESCAP in collaboration with the UBUNTU Consortium of Women Entrepreneurs Associations, India from 20 to 21 December 2021. With the objective of enhancing the knowledge and capacity of women entrepreneurs to use digital marketing tools and e-commerce platforms, both trainings covered topics on how to use e-commerce and digital marketing, including social media platforms, to promote businesses; there were also dedicated hands-on sessions on registering and creating products and services catalogues as well as uploading their profiles as entrepreneurs on e-market platforms, including ESCAP's training platform <a href="https://www.unescap.wesellonline.org/">https://www.unescap.wesellonline.org/</a>. Each training was attended by around 100 participants from the subregion, many of whom had the opportunity to display their products during the networking sessions. # 1. Capacity Building Workshop on "Sustainable Transport Connectivity and COVID-19 Pandemic: Pathways for Greater Resilience and Sustainability"



New Delhi, India, 7-8 October 2021. The United Nations Economic and Social Commission for Asia and the Pacific (ESCAP) and the International Transport Forum (ITF) at the Organisation for Economic Co-operation and Development (OECD) have developed a joint capacity programme on "Sustainable Transport Connectivity and COVID-19 Pandemic: pathways for greater resilience and sustainability" in order to support countries in incorporating into their medium- and long-term transport policies the best practices and lessons learned from the Covid-19 pandemic response, as well as to implement appropriate transport policies that will achieve greater resilience, inclusiveness and environmental sustainability of their transport connectivity. Following the project inception meeting, a sub-regional capacity building workshop was organized from 7-8 October 2021, to support the development and implementation of a sustainable

Dr. Ratna served as a panelist and shared his views on the current trade and investment scenario in the subregion and underscored the role of regional cooperation as countries build back better.

Tofazzel Hossain Miah, Secretary, Prime Minister's Office, Government of the People's Republic of Bangladesh; Ms. Fatima Yasmin Secretary Economic Relations Division, Ministry of Finance, Government of the People's Republic of Bangladesh; and Mr. Ito Naoki, Ambassador Extraordinary and Plenipotentiary of Japan to Bangladesh. Dr. Ratna highlighted some of the studies done by ESCAP and the policy



recommendations relating to sustainable graduation, export diversification, addressing non-tariff barriers and how Bangladesh can go up the value chain in certain sectors like textiles and pharmaceuticals.

IV. South Asian Countries highlight the Importance of Global Climate Action at The UN Climate Change Conference (26th Session of the Conference of the Parties (COP26)





#### Bangladesh

H.E. Ms. Sheikh Hasina, Prime Minister of Bangladesh, noted that Bangladesh is one of the most climate-vulnerable countries, while contributing less than 0.47 per cent of global emissions. She highlighted the establishment of the Bangladesh Climate Change Trust Fund in 2009 for climate adaptation as a measure to address the country's climate challenge, and that the country had thus far allocated 480 million dollars to this fund from their own resources. She further shared that climate-relevant allocation in the country's Annual Development Plans has doubled from USD 1.44 billion in Financial Year 2015-16 to USD 2.96 billion in Financial Year 2021-22 for climate adaptation and resilience building. She also highlighted the implementation of world's biggest housing project for people displaced by climate change in Cox's Bazar. She also noted the government's adoption of the "Bangladesh Delta Plan 2100", a 100-year strategic plan aimed at gradual sustainable development through

adaptive delta management process targets to achieve a safe, climate-resilient and prosperous delta. Furthermore, she underlined the country's extensive domestic solar energy programmes, which have ensured solar electricity to 18 million people over the last few years. She then stated that Bangladesh has submitted an updated Nationally Determined Contributions to the UNFCCC wherein the country has cancelled ten coal-based power plants, and hoped to have 40 per cent of their energy from renewable sources by 2041; the government is also going to implement the 'Mujib Climate Prosperity Plan' - a journey from climate vulnerability to climate resilience and then to climate. She also mentioned that Bangladesh, as the Chair of the Climate Vulnerable Forum and the Vulnerable 20 Group, is promoting the interests of 48 climate-vulnerable countries, and is also sharing best practices and adaptation knowledge with other climate-vulnerable countries through the Global Centre on Adaptation's South Asia regional office in Dhaka. Further, Bangladesh is pursuing to establish a global partnership of the Climate Emergency Pact that would prioritize (a) limiting temperature rise to 1.5 degrees; (b) \$100 billion a year climate finance; (c) ambitious adaptation and mitigation actions; (d) additional and adequate financial mechanisms to address loss and damage and displacement of people due to climate change; and (e) championing nature-based climate solutions. Finally, she urged the countries to work together towards the following five achievable goals: major emitters to submit ambitious NDCs and implement those; developed countries to fulfil commitments of providing USD 100 billion with 50:50 balance between climate adaptation and mitigation; developed countries to disseminate clean, green, and advanced technology to the vulnerable countries at affordable costs; the issue of loss and damage to be addressed, including the global sharing of responsibility for climate migrants; and the need to have a "common global commitment" for leaving a healthier planet for the future generation. #### **Bhutan**

H.E. Mr Yeshey Penjor, Honorable Minister, Royal Government of Bhutan, in Bhutan's capacity as Chair of the Least Developed Countries (LDCs) Group and a highly vulnerable country, called for the scaling up of finance for adaptation, loss and damages, technology transfer and capacity building to enable LDCs to recover from the severe impacts of climate-induced disasters. He highlighted that LDCs do not contribute to greenhouse gas emissions but bear the brunt of climate change impacts and that water resources, agriculture and infrastructure for life, food security and livelihood are at risk in fragile mountain ecosystems of countries like Bhutan. He stated that climate change adaptation was the country's priority, and that adaptation must be supported with grants in finance; he further urged countries to live up to the US\$100 billion climate finance commitment wherein adaptation must receive equal share in climate financing. He shared how Bhutan, under the policy guidance of their Environmental Champion Monarchs, had demonstrated leadership in environmental conservation and that their low emission development policy for climate change and sustainable development goals have been committed. Additionally, he highlighted Bhutan's commitment towards e-mobility in the transport sector and energy efficient housing, and invited investors, governments, multinational donors, INGOs, and the private sector to support green initiatives in the country. He further expressed that countries like Bhutan have been worst impacted due to the impact of the COVID-19 pandemic along with climate crisis, and urged leaders to consider post-pandemic economic support. He further expressed the need for regional cooperation and global support in saving the Himalayas and the livelihoods of 240 million people living within these mountains. He expressed that while Bhutan welcomed the COP 26 Presidency's "climate finance delivery plan: meeting the US\$ 100 billion goal" and contributions committed by partners in the replenishment of the LDC Fund, Bhutan would like to reiterate that climate finance must be predictable, easily accessible, and sustainable based on the priorities and needs of the vulnerable countries. He emphasized that countries must speed up the delivery of ambitious, concrete, and enhanced climate action and support, as COP26 approached its final week. For Bhutan, he reiterated that COP26 must deliver concrete decisions on enhanced ambition, adaptation, loss and damage, robust rule for implementation of market and non-market mechanism that ensures environmental integrity and enhanced financial support for climate action. Lastly, he stated that Bhutan is committed to the principles and objectives of the Convention and Paris Agreement and called on all parties to be flexible, open and constructive to deliver strong climate action and support. #### India

H.E. Mr. Narendra Modi, Prime Minister of India, shared examples of how India was committed to mitigate the impacts of climate change. One of the major commitments included making Indian Railways 'Net Zero' by 2030. He also highlighted India's LED bulb campaign that has been reducing emissions by 40 million tonnes annually, as well as India's initiation of the initiative of the International Solar Alliance, which represents a coalition for disaster resilient infrastructure for climate adaptation. He stated the mantra of "LIFE"-Lifestyle for Environment - to ensure peaceful existence with nature and expressed that LIFE could become a mass movement of the "Environmental Conscious Life Style". Additionally, he presented five nectar elements, 'Panchamrit', to deal with the challenge of climate change, specifically: (a) India would take its non-fossil energy capacity to 500 GW by the year 2030; (b) the country would meet 50 percent of its energy requirements from renewable energy by year 2030; (c) the country would reduce the total projected carbon emissions by one billion tonnes from now till year 2030; (d) by year 2030, India would reduce the carbon intensity of its economy by more than 45 percent, and (e) by the year 2070, India would achieve the target of Net Zero. In his conclusion, he highlighted the need to track climate finances, and that India expects developed countries to provide climate finance of \$1 trillion at the earliest. Read more here.



#### Islamic Republic of Iran

H.E. Mr. Ali Salajegheh, Vice President and Head of the Department of Environment of Islamic Republic of Iran, stated that the Government of the Islamic Republic of Iran is committed alongside with other nations to combat the climate change and global warming. He shared that Iran has an ambitious national plan to cope up with the consequences of climate change. He informed that Iran is in the legal process of ratifying the Paris Agreement, and noted the difficulty the government would face in implementing due to the lack of financial or technical assistance from the international community. #### **Republic of Maldives**

H.E. Ibrahim Mohamed Solih, President of the Republic of Maldives, began his address by underscoring that the island's existence is at stake due to the gravity of the climate change situation. He mentioned the severe erosion on the islands of Maldives and expressed concern regarding inundation of the islands by the sea. He highlighted that if trends are not reversed, Maldives would cease to exist by the end of the century; an increase of temperature rise to two degrees would mean a death sentence for the Maldives. He stated that Maldives is determined to be a part of the global solution to reverse these trends and take the most ambitious climate actions to achieve low-emission development and climate resilient future. He urged major emitters to step up their nationally determined contributions (NDCs) for achieving Net Zero and advised countries to band together to assist the most climate-vulnerable states adapt to climate change. Additionally, he suggested for stringent accountability measures to ensure that all commitments on climate finance are met. Read more here



#### Nepal

H.E. Mr. Sher Bahadur Deuba, Prime Minister of Nepal, reaffirmed Nepal's commitment to the implementation of the Paris Agreement. He mentioned that Nepal had submitted an ambitious Nationally Determined Contributions (NDC) to decarbonize its economy in all sectors, and stated that Nepal aims to reach a net zero emission by 2045. He expressed that Nepal will ensure that 15 per cent of its total energy demand is supplied from clean energy sources and maintain 45 per cent of the country under forest cover by 2030. Furthermore, he mentioned that Nepal had recently approved its Long-Term Strategy, Framework for Loss and Damage and National Adaptation Plan, with a policy of spending at least 80 per cent of the available climate finance to support local climate actions and reaching out to the vulnerable communities through its Local Adaptation Plan of Action. He urged world leaders to recognize the specific climate vulnerability in the high mountains and accord high priority to the mountain agenda in all climate-related negotiations. He underscored that keeping global temperature below 1.5° Celsius is vital for mountain people. To raise awareness on the climate crisis in the Himalayas, he declared that his government would host the Sagarmatha Sambad, a dialogue named after Mount Everest. In addition, he mentioned that Nepal has mechanisms to ensure that international climate finance is channelled to support transformational approaches in implementing adaptation, mitigation and disaster management actions together. In his conclusion, he highlighted that the subject of loss and damage must find a place under article 4.8 of the Convention, and called upon all Parties to make loss and damage a standalone agenda for negotiations and to support the framework of additional financing for loss and damages. He also highlighted that COP 26 must ensure adequate support for adaptation in the most vulnerable countries by scaling up financial, technological, and capacity-building resources. Lastly, he called upon the Parties to agree to a clear roadmap for a new collective goal on climate finance before 2025. Read more here.



#### Islamic Republic of Pakistan

H.E. Mr. Malik Amin Aslam, Federal Minister for Climate Change of Pakistan highlighted two lessons taught by the ongoing COVID crisis, firstly, that mankind cannot fight nature and hope to win, and secondly, that a better world, decarbonized and a nature positive, is out there and possible. He expressed that Pakistan's climate vision is built on two pillars – shifting 60 per cent of the country's energy mix towards clean energy and 30 per cent of its transport on electric vehicles by 2030, and investing in "Nature Based Solutions". He mentioned that Pakistan has announced its complete shift out of imported coal projects, and will be turning the China Pakistan Economic Corridor into a China Pakistan Green Economic Corridor. He then shared examples of real climate action undertaken by Pakistan such as the Ten Billion Tree Tsunami program, Protected Areas

Initiative and Recharge Pakistan, all of which are part of the country's updated Nationally Determined Contributions (NDC). He further highlighted that, utilizing the country's own resources, Pakistan had dropped its emissions to 9 per cent below business as usual (BAU) by 2020 and has developed a pathway to reach 15 per cent below BAU by 2030. Mr. Malik then underscored that while Pakistan is not a major contributor to climate change, the country continues to be on the top ten list of most vulnerable countries for ten straight years, and that the country's forced climate adaptation needs remained between \$7 billion to \$14 billion per annum, almost 70 per cent of which fall in the loss and damage category. He then underlined that private sector initiatives are gaining ground, with technologies becoming available and affordable and with new innovative financial mechanisms like the "Energy Transition Mechanism" and "Nature Performance Bonds" pushing new frontiers. #### **Democratic Socialist Republic of Sri Lanka**

H.E. Mr. Gotabaya Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, expressed that sustainability is at the core of the country's national policy framework, and that its updated Nationally Determined Contributions aimed to reduce emissions towards achieving carbon neutrality by 2050. He highlighted that the country had prioritized the enhancement of forest cover, with initiatives underway to increase carbon sequestration capacity by 7 per cent by 2030, and that Sri Lanka would increase the contribution of renewable energy sources to 70 per cent of national energy needs by 2030. He mentioned that Sri Lanka is a co-lead of the "Global Energy Compact for No New Coal Power", and leads the Action Group on Mangrove Ecosystems and Livelihoods under the Commonwealth Blue Charter initiative. He also said that Sri Lanka recently restricted imports of chemical fertilizers, pesticides, and weedicides, and, in 2019, spearheaded the Colombo Declaration on Sustainable Nitrogen Management, which seeks to halve Nitrogen waste by 2030. He concluded by expressing that Sri Lanka welcomes investments, technology transfers, and climate financing for its ambitious sustainability efforts, along with broader development assistance to support recovery from the COVID19 pandemic. He also stated that climate change was disproportionately impacted developing island nations, and that it was essential for the world's largest emitters of greenhouse gases to fulfill their national commitments and assist developing nations navigate through the climate crisis. #### Turkey

H. E. Mr. Murat Kurum, Minister of Environment, Urbanization and Climate Change of Turkey, mentioned that Turkey is exposed to disasters such as floods, landslides and forest fires, the frequency and severity of which has increased every year, and that Turkey has been fighting against these climate-induced crises for 20 years. He mentioned that Turkey has finally become a Party to the Paris Agreement as a result of the unanimous decision of the Turkish Grand National Assembly, and that immediately thereafter, the President of Turkey announced the country's vision of 'Green Development' towards the '2053 Net Zero Emissions' target. He elaborated that government has named his ministry as the 'Ministry of Environment, Urbanization and Climate Change'; that Turkey has entered a new period of developing more effective strategies and policies in its fight against the climate crisis. He highlighted that Turkey is preparing the Climate Law, which contains policies, targets and regulations for climate change; is updating its Climate Change Strategy and Nationally Determined Contribution with the net zero emission target of 2053; has activated the action plan necessary for harmonization with the European Green Deal; is establishing the infrastructure of the Emission Trading System, which will support investments in climate-friendly and clean production technologies; is making the provinces resistant to climate change along with Turkey's Regional and Local Climate Change Action Plans; and is rolling out the Zero Waste Project. He further shared that Turkey has increased its forest assets from 20.8 million hectares to approximately 23 million hectares, and that by increasing the share of renewable energy sources in Turkey's installed capacity to 53 per cent, the country has reached the 12th place in the world and the 5th in Europe in this area. He said that Turkey is building a national garden in each city, giving life to biological diversity with ecological corridors, and has increased its conserved natural areas to protect their natural resources against the danger of pollution and extinction. Finally, he emphasized that it is imperative that countries that have historical responsibility for the emergence of the problems that cause climate change should take responsibility with the same sincerity, and that climate change is not just an environmental issue, but a development and security issue as well that deeply affects all countries. He affirmed that Turkey will continue to do its part in the fight against climate change and in the protection of the environment in the future, and will continue to stand by countries most affected by climate change.
